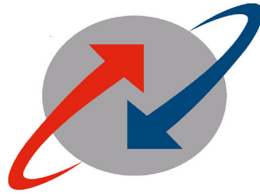

Sub: Holding of 3rd membership verification process through Secret ballot for electing majority representative union of non-executive employees in BSNL – Finalisation and supply of electoral rolls to the authorized representatives of participating unions regarding

This is in continuation of this office letter of even number dated 4th August, 2006 followed by reminder dated 1st September, 2006 regarding preparation of revised electoral rolls for election of majority representative union of non-executive employees in BSNL and review of number of polling booths in the SSAs. Despite the fact that the Circles were advised to furnish this information to this office by 8th September, 2006, yet most of the Circles (A&N, ALTTC, Assam, Bihar, BRBRAITT Jabalpur, Chennai Distt., Haryana, HP, J&K, Jharkhand, Karnataka, Kerala, MP, NE-I, NE-II, NTR, T&D, Tamilnadu, TF Kolkata, TF Mumbai, UP (West), West Bengal & BSNL C.O.) have yet to furnish the same. These Circles are once again advised to furnish the requisite information to this office positively by 26.09.2006 so that the Election Commission could be timely contacted for supply of ballot boxes.

2. Further, based on the practice followed at the time of second membership verification, the following Schedule for finalization of electoral rolls has been decided :-

- (a) The revised electoral rolls may be displayed by 28.9.2006 and also provided to the representatives of the participating unions at SSA/Unit HQrs. level from 28.9.2006 onwards. The SSA/Unit level representatives shall be nominated by the Circle Secretaries or General Secretary/Secretary General, as the case may be, and the Circle representatives shall be nominated by the respective General Secretary / Secretary General.

- (b) Objections on the electoral rolls, if any, will be submitted by the Unions to the concerned local authority latest by 09.10.2006. In case no response is received by the stipulated date, it will be presumed that the Union(s) is/are not having any objection on the electoral rolls provided to them.
- (c) The concerned local authority shall finalize revision of electoral rolls, after addressing the objections received from unions, if any, by 16.10.2006.
- (d) The Circles shall advise the unions to submit No objection on the revised electoral roll, if already not submitted, by 23.10.2006. In case, no response is received by the due date from any union, it will be presumed that the concerned union is not having any objection on the revised electoral roll.
- (e) The Circles shall display the final voter lists by 30.10.2006 and also communicate a list indicating the final number of voters in a Circle to this office by 31.10.2006.

3. You are requested to kindly ensure that the instructions contained in the preceding paragraph are implemented scrupulously in all the field units.
