The Election Commission of India was requested to provide 4602 nos. of ballot boxes (@ 2 per polling booth) for conducting 3rd membership verification through secret ballot, the details of which have already been circulated vide this office letter of even number dated 3rd November, 2006. Election Commission of India, vide its letter under reference, addressed to the Chief Electoral Officers of all the States & Union Territories (copy enclosed) has agreed to supply 4602 nos. of ballot boxes on loan basis to BSNL, the break-up of which is given below:-

2. As already informed vide this office letter of even number dated 16.10.2006, the date of Polling has been fixed for 19.12.2006. Accordingly, it is requested that the necessary action for procurement of Ballot Boxes from respective Chief Electoral Officers of States/Union Territories & their distribution to all the SSAs/Units under your control may be in accordance with the time schedule indicated in the "**Procedure for conducting membership verification....**" circulated vide this office letter of even number dated 6th November, 2006. The progress in this regard may be intimated to this office.

3. The above table reveals that some Circles have been clubbed within a State and some offices of CGM, Telecom Stores, Kolkata shown with other Circles. In order to ensure smooth distribution of ballot boxes, the following arrangement is suggested: -

- NTR shall collect the ballot boxes on behalf of BSNL C.O. and Delhi unit of CGM, TS, Kolkatta and arrange its distribution.
- MP Circle shall collect the ballot boxes on behalf of BRBRAITT Jabalpur, T&D Circle, TF, Jabalpur (including Richhai) & Jabalpur unit of CGM, TS, Kolkatta and arrange proper distribution.

- Maharashtra Circle shall collect the ballot boxes on behalf of TF Mumbai & Mumbai unit of CGM, TS, Kolkatta and arrange proper distribution.
- Chennai Telephone District shall collect the ballot boxes on behalf of Tamilnadu Telecom Circle & Chennai unit of CGM, TS, Kolkatta and arrange proper distribution.
- UP East Circle shall collect the ballot boxes on behalf of UP West Circle & ALTTC, Ghaziabad and arrange proper distribution.
- Kolkatta Telephone District shall collect the ballot boxes on behalf of WB Telecom Circle, Telecom Stores, Kolkatta & TF Kolkatta and arrange proper distribution.
